

# MegLIFE

Meghalaya Livelihood Improvement through Forest Enhancement Project (MegLIFE)



Jungle clearance activities







Multiple jungle clearance activities are ongoing at various locations such as Bangsi Minol, Kopogre village, Tochapara village, and others, along with advance work like lining and staking at sites including Adugre Rongram and Tosekgre Rongram. PA visits for monitoring are conducted at places like Rongribo Watregre VPIC. Ongoing efforts also include jungle clearance at Imsambal Village, Demthring village, and Dombagre, alongside continuation of advance work and jungle clearance at multiple blocks and villages such as Tosekgre, Balupara, and Thapa Dangre Community Reserve. Additionally, activities like line and staking at ANR Plantation sites and demonstrations in Songsak Block are in progress.



On May 1st, 2024, the BPM, Sir Sitaram, Coordinator for MegLIFE and MegARISE in Garo Hills Region, and Sir Ivan Arengh, DPM in WGH, visited Damjongre Group 2 village to monitor progress on the upcoming plantation project and inspect an existing water borehole drilled by the Central Water Board, potentially for a planned RCC water tank project.

"SHG Awareness & Development Events: Highlights"





Several events aimed at enhancing Self Help Group (SHG) awareness and development occurred across various Blocks and villages. Notable activities included SHG gradation visits to Rompa, Karabalapara, Emandurabanda, Rajasimla Songgital, Mittegittim, and Jajilgittim clusters, as well as meetings on Integrated Village Cooperative Societies (IVCS) and SHG awareness. In addition, discussions on record maintenance took place, focusing on Challang, Chibasal, Tekra, and Minrong SHGs of Rongreng Nokat under Songsak Block, culminating in the decision to form two new SHGs due to some groups' reluctance to convert to SHGs. Staff involvement included Programme Associates, an Assistant Manager, and a Forester.



Community nurseries have been set up in different Blocks across various villages, managed by VPICs, to grow plants for the upcoming year 2024 in specified plantation areas.

"Springshed Survey and Management Activities"







The MSLC team conducted Springshed survey activities in various blocks and villages, including Gitokgre VPIC under Samanda Block and Bawegre VPIC under Tikrikilla Block. Community interactions and field visits were carried out with Master trainers, FE, GIS personnel, and BPM I/c, focusing on identifying critical springs and learning opportunities. Additional visits involved Springshed management activities with SPMU and MegArise teams, aiming at collaborative efforts for effective management. Positive responses from villagers indicated a willingness to adopt necessary precautions for Springshed management.

### Halfmoon terracing activities







Half moon terrace initiatives are underway in various blocks and villages. In Malchapara, Betasing Block, SWGH, they were demonstrated by FE and PA Forester. Dorakgre VPIC is currently engaged in ongoing half moon terracing activities. Furthermore, on May 2nd, 2024, a feasibility assessment for SWC was conducted, alongside a demonstration of half moon terracing at Khaldang Tunaturam village in Resubelpara Block

"MegLIFE Rongram Village Evaluation Visit: Progress and Assessments"





On May 2nd, 2024, the Rongram Block's BPM, accompanied by the DPM and the MegARISE team, conducted a visit to Ading Nokat & Tosekgre Rongram to evaluate the progress of the MegLIFE Rongram villages. During the visit, the team inspected the advancement of the Community Hall and Community Nurseries in both villages, along with five sites designated for the Ading Nokat Plantation. They also interacted with VPIC members and assessed the status of ongoing work. As of now, two plots have been fully cleared and staked, while jungle clearing and staking are in progress for three other plots.

### "Community Engagement: MegLIFE Team's Visit to Bandigre VPIC"







On May 1st, 2024, the MegLIFE Samanda Block BPMU team visited Bandigre VPIC to address several important topics. These included explaining the Direct Benefit Transfer (DBT) system for wages, suggesting payment through designated VPIC members due to banking limitations, raising awareness about the Integrated Village Cooperative Society (IVCS), and encouraging the formation of Self Help Groups (SHGs), which attracted the interest of 20 households. Additionally, plans were discussed for distributing saplings for planting activities, with villagers ready to install bamboo fencing to protect the saplings overnight.

### ENTRY POINT ACTIVITY - COMMUNITY HALL

The construction of 370 community halls has been sanctioned under EPA of MegLIFE. Initial phases of site preparation is underway.

On 6th May 2024, MegARISE Umiew Catchment team visited 6 villages (Pombot , Demthring , Madan ingsyiem , Mawkhanpasir ) for verification the feasibility of the land for setting up new nursery under MegARISE Project . And on the same day , Smt A. Raajshree, IAS, BDO , Mylliem Block with line departments had a join inspection to Lumdewsaw and Mawsawa village situated within the Umiew Catchment area. These villages were chosen for inspection, indicating a focus on areas crucial for environmental conservation and community development and to look around for an effective convergence going forward.

And on 7th May 2024, the team visit to Mawnarian under Mylliem C&RD Block, Iewpomtiah and Umiew Maw U Sam under Mawryngkneng C&RD Block and Umtyngngar under Khadarshnong C&RD Block.

### SUSTAINABLE LAND MANAGEMENT, MEGHALAYA



The 3rd Regular Meeting of the Sustainable Land Management Meghalaya Project (SLM) was held on 06 May 2024 at SLM headquarters to discuss update on works carried out by the Project Management Unit (PMU), the IMC availability for the upcoming months, the status of the Operational (OM), Manual procurement-related updates, and other business matters. Participants included Smt. Isawanda Laloo (IAS), Project Director (PD), SLM, Shri. Jun J Momin, Deputy Project Director (DPD), SLM, Dr. Florian Wieneke, Portfolio Manager NRM, KfW, the PMU team, and the IMC team.




Village Organization Implements Innovative Farming Practices in Umkrem Village, Eastern West Khasi Hills
In a village organization meeting focused on enhancing farming techniques, the following activities took place: an ATM Model was established at LF Balakyntiew's field with diverse crops sown including carrot, radish, peas, turnip, cucumber, coriander, beans, long beans, and broad beans. Natural farming practices were implemented, including seedling treatment with Beejamruth and soil enrichment using Ghana Jeevamrutham mixed with FYM. Border crops such as cucumber, peas, and beans were sowed around maize fields for space optimization. Attendees visited a buckwheat field in its flowering stage and recommended Egg Amino Acid spray for plant health during pollination. During the meeting, topics discussed included Pre-Monsoon Dry Sowing (PMDS), relay sowing in ATM Models, managing pest infestations naturally, readiness of lands for paddy sowing, and ensuring availability of Ghana Jeevamrutham. The session was attended by ICRPs.

### SUSTAINABLE LAND MANAGEMENT, MEGHALAYA











The Rongbok Abri Village Self-Help Group, led by farmer Cribilla Momin, conducted agricultural activities in Mejolgrewancho Village, Dombo Rongjeng Block, East Garo Hills. They prepared beds and applied 15 kg of Ganajeevamritham biofertilizer to enhance soil fertility. They also treated seeds of 12 types of vegetables and greens with Bijamritham before planting them. The group is focused on mass-producing agricultural inputs to support local farmers while aiming to ensure timely availability, reducing costs, and facilitating resource mobilization within the community.













NF farming activities in Cham Cham, EJH

In East Jaintia Hills' Wapung Block, Natural Farming Farmers in Cham Cham Village established kitchen gardens and models, visited a buckwheat field, and planted tomato, ladyfinger, beans, peas, and cucumber. The vegetable seeds were treated with Bijamruth and Ghana Jivamrutham was applied after planting to enhance growth and soil fertility. Farmers also collaborated on planning Pre-Monsoon Dry Sowing (PMDS). The activities were attended by farmers and lead farmers.

### "Site Inspection Visits and Meetings by GFA"


